The Investment Advisory Team also promotes synergies with ADA's other institutional activities and technical assistance (TA) activities.

The position could either be based at the ADA headquarters in Luxembourg or remotely in Africa or Asia according to the candidate's profile and specific geographic assignment.

You will oversee and strengthen ADA's investment advisory activities in Africa and/or Central Asia. You will thereby enable microfinance institutions to better respond to the needs of people excluded from traditional financial services.

## Your responsibilities:

- Identify financial partnership opportunities with inclusive finance institutions in Africa and/or Central Asia;
- Perform due diligence of potential partners;
- Negotiate with the institutions;
- Prepare investment dossiers based on the financial and social analysis of the institutions;
- Collect legal documents and provide support during the disbursement phase;
- Monitor the investment portfolio according to the assigned region;
- Take part in certain sector key events such as investor fairs and conferences;
- Develop partnerships with other actors in the sector.

## Your profile:

- University degree in a field related to economics/finance;
- A minimum of 3 years' experience in inclusive finance;
- Field experience in at least one of the target regions (Africa and/or Central Asia);
- Capacity to carry out a financial analysis of microfinance institutions;
- Rigour, autonomy, proactivity, ability to work in a team;
- · Excellent analytical and summarising skills;
- Negotiating skills;

- French language skills would be an advantage;
